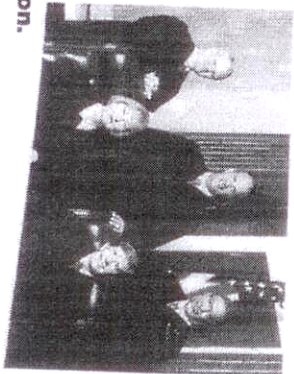
Accordingly, no action can be taken at this time by the Supreme Court concerning this matter.
