

IDENTIFYING INFORMATION

Jonathan L Peterson is a 56 year old male with graying hair and clean shaven. He was dressed casually and appropriate for the interview. He reported that he is single and lives alone in Burley Idaho. His attitude during the assessment was open and positive. He did express some feelings of nervousness, which is common for this situation. He stated that his motivation for the assessment was to determine his mental health status because he was previously told that he was "delusional."

DESCRIPTION OF INCIDENT

Mr. Peterson reported that he has a history of handing out flyers in public places that support his political beliefs. He stated that he was arrested on June 13, 2011 for disorderly conduct. He related that on this day he had gone to Burley Idaho's City Hall and asked to see the Mayor in order to express his opinions on the Controlled Substance Act. Mr. Peterson said that the clerks were behind glass and several of them pointed towards the door, indicating that he needed to leave. He reported that after leaving City Hall he went to the Sheriff's office, which is in the same complex. He stated that he entered the foyer and reached for the security phone to announce himself. Mr. Peterson related that three Sheriff deputies came out of the office and he told them that he wanted to make a citizen's arrest of the district Judges. He said that he then left the Sheriff's office foyer and started to walk towards the Court House, also in the same complex. Mr. Peterson reported that a police officer said, "Stop, I want to talk to you about what you are doing." He stated that he continued walking slowly and told the police officers, "Come with me." He related that he was then tackled from behind by the three officers and placed under arrest.

SOCIAL AND PERSONAL BACKGROUND INFORMATION

Mr. Peterson reported that he was born in Moscow, Idaho and that he is the youngest of five children born in his family of origin. He stated that his parents adopted another son when Mr. Peterson was 12 years old. He related that his parents never divorced and were still married at the time of his father's death in 1989. When asked about his relationship with his parents as he was growing up, Mr. Peterson said that his relationship with his mother was "awesome, she was very murturing." He reported that he remained close to his mother until her death in 1998 from cancer. He stated that he was more fearful of his father, but that for the most part their relationship was good. Mr. Peterson related that his relationships with his siblings as a child were, "good. I was the baby and they liked to do things with me," He said that his relationships with his brothers and sisters have become more distant since the death of his parents. Mr. Peterson reported that his childhood was "really good." He stated that he participated in sports and had many friends. He related that when he was 12 years old his oldest brother fathered a child and his parents adopted the baby when the baby was three months old. When asked if there was physical, emotional or sexual abuse in the home. Mr. Peterson reported that his father used corporal punishment, but he did not describe it as abusive. He stated that between the ages of five and nine one of his brothers and some of his brother's friends would touch him inappropriately sexually. He related that there was never penetration, although his brother would try to trick him into having oral sex. He said that the act was never completed.

INTIMATE RELATIONSHIP HISTORY & CURRENT RELATIONSHIP STATUS

Mr. Peterson reported that he has been divorced since 1992. He stated that he has been married once and that he was married for 12 years. When asked why the marriage ended, he related that he and his ex-wife divorced in order to be able to keep their children medically insured under Medicaid. Mr. Peterson said that he continued to live very close to his ex-wife and children and saw them daily. He reported that after several years his ex-wife and children moved about nine miles away and this created more of a distance between them. He stated that his ex-wife and one of his daughters moved to Boise, Idaho when his daughter started college, and although they still speak often, he is not able to have as much contact. Mr. Peterson related that he and his ex-wife had three children together. He said that his oldest child, Michael, shot himself when he was 15 years old in 1997. He reported that he has two daughters, ages 28 and 24 years old. Mr. Peterson stated that his ex-wife has a son from a previous marriage that is three years older than Michael. He related that he remains close to his daughters, although he is not as close to his step son due to his step son having problems with substance abuse.

EDUCATION & EMPLOYMENT HISTORY

Mr. Peterson reported that he attended North Vicksburg High School, in Mississippi. He stated that he stopped attending school in the 11th grade, returned for a few months his senior year and again stopped attending. He related that he obtained his General Education Degree (GED) and enlisted in the military. Mr. Peterson said that he received an honorable discharge from the

Army after several months of service. He reported that it was determined that he was not suitable for service.

Mr. Peterson stated that he owns his own business, JLP Digital, in which he works with computers and other electronic devices. When asked if he likes his current work, he said, "Yes, but what I would really like to do is charity work." He related that he worked in the construction field for 17 years, until he was diagnosed with Grave's Disease.

PHYSICAL & MENTAL HEALTH HISTORY

Mr. Peterson reported that he was diagnosed with Graves's Disease in 1995. He stated that he received treatment for the disease in 1998. The treatment destroyed his thyroid and he is now required to take daily medication. In addition to thyroid medication Mr. Peterson related that he takes medication for high blood pressure, and Vicadin and Soma as needed. He also showed me a medical marijuana card issued in California. He said that marijuana relieves his pain more effectively than does the Vicadin or Soma.

Mr. Peterson reported that he has experienced symptoms of depression and anxiety in his history. He stated his symptoms started shortly after his father's death. He related that he tried taking antidepressant medications for a very short time, but did not find them to be effective. He said that he has discovered that physical activity, such as walking, works well for him to keep his symptoms of depression and anxiety under control.

ALCOHOL & DRUG HISTORY

Mr. Peterson reported that when he was arrested for disorderly conduct he was also charged with possession of paraphernalia. He stated that he had a small marijuana pipe in his possession at the time of the arrest. He related that he has not used any substances since his arrest in June 2011. Mr. Peterson said that his substance of choice is marijuana and that he uses THC for pain management.

He reported that his oldest brother has problems with substance abuse and that he believes that he is a "drug addict." He stated that neither of his parents used substances.

Mr. Peterson stated that he has never had treatment for substance abuse or dependence and he does not meet criteria for a substance abuse disorder.

Mr. Peterson reported that he has had one arrest, which occurred recently. He stated that he was arrested for disorderly conduct and possession of paraphernalia on June 13, 2011. A Background check was not done to confirm this.

Jonathan Peterson is a 56 year old male that requested a mental health assessment because he was told that he has a delusional disorder. He came to the assessment dressed casually and appropriately. Although he exhibited a bit of nervousness he appeared to be honest and forthcoming with his responses to the assessment questions. Mr. Peterson reported that he had recently been arrested for disorderly conduct and possession of paraphernalia in Idaho. He stated that his arrest was due to requesting to make a citizen's arrest of the district Judges. Mr. Peterson is passionate about his religious beliefs and his constitutional rights. He is vocal about his beliefs and wants to share his tenets with others. During the assessment he was able to express an understanding of why the techniques he used to articulate his opinions were considered to be outside of the law. In regards to whether or not Mr. Peterson has a Delusional Disorder clinical judgment is sometimes difficult to make. Some comments that appear defusional may be true. In contrast, some reports that initially seem believable may later be identified as delusions as more information comes to light. Clinical judgment that delusions are present should be made after taking into account the degree of plausibility, systemization, and the possibility of cultural beliefs that are different from one's own. This makes the distinction between a true observation, a firm belief, an overvalued idea and a delusion sometimes a difficult task. Often it is the extremeness of the client's beliefs and behaviors that are telling. As mentioned above, Mr. Peterson is passionate about his beliefs. In my opinion, his beliefs are plausible. In these times of political extremes, his behaviors seem to mirror those of many others with strong political beliefs. It is important that Mr. Peterson develop methods of expressing his views that do not break the law or create problems for him. However, in my clinical opinion, after conducting this assessment I do not believe that Mr. Peterson has a July 17,2011 delusional disorder.





Referral Information: Mr. Peterson is a 56 year-old, White male. The Honorable Mick Hodges, Magistrate Judge, ordered the defendant to complete an evaluation pursuant to Idaho Code § 18-211 following charges of disturbing the peace and possession of drug paraphernalia. Mr. Peterson is represented by Robert Squire, Attorney at Law.

Mr. Peterson was assessed in the Mini Cassia Criminal Justice Center. He was directly observed by the examiner for approximately 2 % hours. At the outset of the examination, the examiner presented the defendant with a Forensic Notification of Purpose. The examiner observed Mr. Peterson as he read the document. In addition, the examiner explained in simplified language each component of the notification and allowed Mr. Peterson to ask questions. He was advised that his participation would not be coerced and that he could seek consultation with defense counsel in the event he had additional questions about or during the evaluation. The examiner explained the purpose of the evaluation, the activities involved in the evaluation, the limitations to confidentiality, and the procedures the examiner would follow upon completion of the evaluation. Mr. Peterson stated he understood the purpose of the evaluation and indicated his desire to proceed with the evaluation.

Sources of Information: Clinical Interview by Dr. James A. Tyson (6/30/2011); Competency Interview by Dr. James A. Tyson (6/30/2011); Mini Mental State Exam (6/30/2011); Document Review: Treatment Records from Dr. Bernard Boehmer for medical treatment from 12/15/2004 until 2/25/2011

Mental Status: Mr. Peterson presented in county issued attire. He was pleasant and cooperative with the examiner. He described his mood as "good." His affect was appropriately broad. Although there was no evidence of hallucinations, Mr. Peterson did evidence delusional thought content. However, his delusions do not appear to compromise his gross cognitive functioning.

To wit, Mr. Peterson completed a brief cognitive screening measure to assess the presence of gross neuropsychological impairment. On this measure, the

defendant had little difficulty completing relatively simple tasks in the areas of orientation, registration, attention and calculation, recall, construction and language (MMSE = 29/30). Therefore, gross cognitive functioning appears to be intact.

Although no formal assessment of intellectual functioning was conducted, Mr. Peterson appears to be of average intelligence based upon his completion of a General Equivalency Diploma and a post-high school reading level as assessed by the Wide Range Achievement Test Third Edition - Reading Subtest (Standard Score=101).

Despite a history of treatment for anxiety and depression with antidepressant medication, Mr. Peterson denied most psychiatric symptoms. However, there is substantial evidence that he meets criteria for delusional disorder.

Delusional disorder is an illness characterized by the presence of nonbizarre delusions in the absence of other mood or psychotic symptoms, according to the Diagnostic Manual of Mental Disorders, Fourth Edition, Text Revision (DSM-IV TR). The DSM-IV TR defines delusions as false beliefs based on incorrect inferences about external reality that persist despite evidence to the contrary and beliefs that are not ordinarily accepted by other members of the person's culture or subculture. Non-bizarre refers to the fact that the type of delusion is about situations that could occur in real life, such as being followed, being loved, having an infection, and being deceived by one's spouse.

In Mr. Peterson case, he holds the grandiose belief that he has been ordained by God to share his truths with those less fortunate than he. Specifically, he holds the belief that laws giving doctors the right to prescribe controlled substances but limiting other persons access to these medications is unconstitutional. His anger associated with what he views as unconstitutional laws is directed primarily at physicians, who control his access to medications through prescriptive authority, and judges, who facilitate this inequity through misinterpretation of Constitutional law.

Mr. Peterson denied a family history of alcohol abuse. He reported that he rarely uses alcohol. However, he reported daily usage of cannabis for purposes of pain management.

Understanding of the Legal Situation: When questioned regarding his attorney, Mr. Peterson was able to identify his attorney as Robert Squire. Mr. Peterson reported having a positive opinion of Mr. Squire, but expressed

disappointment that he did not "know him better." He had no difficulty describing the current charges he faces, but could not describe the potential penalties.

Mr. Peterson appears to have an adequate factual understanding of the current proceedings and the roles of the various actors. Mr. Peterson stated that the judge was in charge of the court and that he listens to and weighs the evidence in the case and makes the final decision of guilt. Mr. Peterson stated that his attorney assists in his defense, attempts to have the defendant found not guilty, and attempts to minimize the punishment. Mr. Peterson recognized the prosecutor as the individual responsible for bringing the charges and attempting to have him found guilty.

As persons with delusions selectively attend to available information and make conclusions based on insufficient information and have difficulty understanding others' intentions and motivations, there is some reason to be concerned that the defendant's delusions could undermine his rational decision making abilities.

Due to his delusional disorder, Mr. Peterson clearly has difficulty appreciating the wrongfulness of his conduct. He believes that he was arrested for attempting to inform the judges of their misinterpretation of law, which is his right as a citizen and duty as a servant of God. Additionally, he believed the officers that ultimately forcibly arrested him where initially sympathetic to his predicament. This appears to suggest a capacity for gross misinterpretation of the world around him.

As such, the evaluator asked Mr. Peterson if he would consider a plea agreement. He said he would not and added that the prospect of additional jail time did motivate him to consider one. According to the defendant, jail has afforded him an opportunity to commune with God and share his truths with those who will listen.

Conclusions Regarding Competency to Stand Trial: Mr. Peterson appears to have a rudimentary understanding of the judicial process-including its principal players. However, his delusional disorder negatively impacts his ability to engage in rational consideration of important issues during the current proceeding.

Overall, it is the opinion of this examiner that Mr. Peterson is NOT competent to proceed at the current time. Mr. Peterson does not appear to possess the capacity to make informed treatment decisions.




